3. Referee In Chief's Report - Serge Gervais

- RIC Meeting Nov 8 2021
 - Game sheets must be reviewed for accuracy. Officials are encouraged to print a copy and keep in their bags, in case you need to complete a Game Incident Report (GIR). As a reminder, we do not discuss potential suspension situations with coaches.
 - As of Nov 8, any minor hockey participant is suspended if not fully vaccinated for Covid-19. Participant can be reinstated 14 days after second dose.
 - U9 Game sheets are required. Only major penalties and reportable offenses are recorded. For penalty
 reporting, we will call the penalties after the offending team gains possession of the puck, and will escort
 the guilty player to his bench.
 - U11 Penalties are 1 minute for a minor, and 3 minutes for a Major, for House League only. No changes of penalty duration for U11 competitive.
 - o "Rule of the Week" videos will be posted on the Cumberland Refs website, but are being sent out by HEO on a weekly basis. Officials should take the time to view the videos.
 - o Referee of the Month award D12 will nominate 1 official in our chosen month for the award.
