- Covid Screenings
  - o CRA will continue Covid-19 pre-screening through the end of the season.
- Police Record Checks (PRC)
  - Mandatory per HEO for all officials 19 years of age and older. If you are turning 19 during the season, you
    must apply for a PRC with a Vulnerable Sector Check. Renewal required every 3 years. If you have a valid
    PRC and are charged with a crime, you must self-report to Steve.
  - Official profiles on the website have been updated to include PRC details, including expiry. Officials must ensure their PRC's remain current, and take action when necessary.
