3. Referee In Chief's Report - Serge Gervais

- RIC Meeting Dec 7,, 2022
 - Meeting was cancelled, will be rescheduled for January.
- District 12 Meeting November 24, 2022
 - o Investigations of incidents were conducted, some remain unresolved
 - District has spare ice available. CRA may hold another on-ice training session in January. To be confirmed.

Miscellaneous

- Many GM penalties being issued against coaches, including green armband situations. Officials are encouraged to continue to assess these types of penalties and complete a GIR when warranted.
- Several GIRs also document ejection of spectators; HEO concerned it may be happening more than what's being reported. Again, officials are encouraged to continue document these incidents when they occur.
- These types of incidents serve as a reminder that we as officials will face difficult situations, and that it is important to deal with these situations in a professional manner.
- Green armbands to be worn on the left arm where the red band would normally be worn. If refereeing in the 3-official system, green armband on the left arm, red arm band on the right arm.
- HEO crests must be worn when doing any HEO games. Similarly, for those officiating outside of HEO, the proper crests should be worn for any of those leagues (OWHA, men's leagues, high school, etc.)
- O Hockey Canada released its report on discrimination from the 2021-22 season on December 2. It can be viewed on the Hockey Canada website.
- o HEO has also released its own report on discrimination; can be shared with officials upon request.
- HEO AAA Reset Plan planned for the 2023-24 season. Aims to provide unified AAA program from U12-U18 levels with Hockey Canada player development standards. Key step is public consultation. If interested in providing feedback, please advise and the information will be provided.

 provide details on supervisions and / or in-game issues you would like clarifications on.
- Participation in the mentorship program is important and it is mandatory for new / newer officials.
 Disciplinary actions will be taken where needed.
