#### 3. Referee In Chief's Report - Steve Harrison

- a. HEO RIC Meetings

- **b.** District Meeting October 19

# a) House League (HL) – Lucio Paiano

- Dukes U9 showcase was successful. Some first-year officials were able to take some games
- U11 / U13 tournament November 24-26 weekend is completely assigned. First-year officials have been paired with senior officials for some U11 games, and some shadow games will take place in the tournament.
- Some new officials have completed their shadow games and are starting to be assigned games in blocks of 2 or 3 games. Nearly all first-year officials will be complete their complement of shadow games by mid-December. Thereafter, first-year officials won't normally get paired together for their next few assignments.
- Email for December availability sent today, assigning to begin tomorrow. Ensure your availability is updated.
- Bell Capital Cup will be happening this year, between Christmas and New Year's. Normally a mix of house league and competitive games, we won't know exact levels until just before Christmas.
- U9 from January 15 2024 onwards, U9 will play in full-ice games.
- U15 / U18 tournament will be February 9-11. Should be lots of games across multiple rinks.
