3. Referee In Chief's Report – Steve Harrison

- a. Major penalty when there's an injury
 - When selecting the penalty type, ensure to select "e" within the appropriate rule reference.
- b. HEO Rule of the Week Video Spectator Ejections
 - Video was shown at the meeting and discussed. Note that this is HEO policy and not Hockey Canada policy. Officials should also attempt to get the name of the spectator if possible, and include it in the Game Incident Report if provided with it, or make a statement in the Report if unable to be attained.
- c. Dressing Room Policy Update "Minimum Attire"
 - All officials strongly encouraged to (re)familiarize themselves with the full <u>Ontario Hockey Dressing Room Policy</u>. Policy memo with links was sent to all officials on January 29, 2024; policy came into effect on February 1, 2024.
 - Particular attention to "Minimum Attire" as defined in Section 2.4. Of note, chest and pelvic areas must be covered.
 - Showers are permitted within officials changing rooms, minimum attire and shower recommendations apply.
- d. Rule 6.3 Face-Off Locations
 - We examined situations within the rule book to cover a variety of situations.

4. Secretary Report – Neil Armstrong

- Attendance consistent across the first 5 body meetings, remains much improved compared to previous seasons.

5. Assignors Reports

a) House League (HL) – Lucio Paiano

- U15/U18 tournament went well. Organizers were very happy with the quality of officiating and wanted that message to be passed along to our officials. Great job!
- Assigning for February 75% complete. Last week of February and games for the first week of March will be assigned shortly. Ensure your availability is updated through to ~March 10 if you are hoping to be assigned to some games in this period.
- Playoffs will start on March 17 and typically last 2 weeks, but may go longer due to Easter weekend being on the last weekend of March. Playoff schedule is expected to be received from the District by ~March 10 and assigning will begin immediately. Ensure by March 10 that your availability from March 17 – April 7 is updated.

b) Competitive – Serge Gervais

- Competitive playoff schedules trickling in, games are being assigned as they're received.
- Only U13RB Grads team is advancing on the upper bracket of the playoffs. All other teams are in round robin format, and will see only a couple of games each within Cumberland.
