5. Assignors Reports

a) House League (HL) - Lucio Paiano

- U9 games are now full-ice games for the remainder of the season. For HL games, they will be in the 2-official system, and will follow the same guidelines for penalty duration as is done in U11 (1-minute minors, 2-minute double minors, 3-minute majors).

b) Competitive - Serge Gervais

- U9 competitive games are also now full-ice games and are assigned in 3-official system. Standard penalty durations apply.

- The competitive playoffs normally start by mid-February. Games can be assigned / cancelled on short notice so ensure your February availability is up to date.
